

Village of Fruitvale Public Hearing

The Village of Fruitvale Council will be holding a public hearing on Tuesday, March 8 at 5:00 pm to hear concerns from the public on the proposed amendment bylaws to the Official Community Plan and the Zoning Bylaw.

The 'Village of Fruitvale Zoning Bylaw 846, 2013 Amendment Bylaw 937, 2022' is a bylaw to rezone the area shown in red on the map to the right from RU1- Single and Two Family to P3 - Utilities.

The 'Village of Fruitvale Official Community Plan Bylaw 835, 2011 Amendment Bylaw 938, 2022' is a bylaw to redesignate the area shown in red on the map to the right from FRVL - Residential (1 and 2 Family) to Institutional on the Future Land Use Map marked as Schedule 'F' in Bylaw 835, 2011.



All persons who believe that their interest is affected by the proposed bylaws and wish to submit comment for consideration by Council concerning the matters contained in the bylaw may do so by attending the Public Hearing, or providing comments in writing to Box 370, Fruitvale, BC V0G 1L0 or by email to info@village.fruitvale.bc.ca. Written submissions will be accepted up to 3:00pm Tuesday, March 8, 2022.

Attention all Beaver Valley Seniors - Changes to the BV Age Friendly Program

Beaver Valley Recreation is in the process of transitioning over the Age Friendly Program from the Village of Fruitvale to the Regional District of Kootenay Boundary. This transition will take us a little time to hire a new Age Friendly Coordinator and get the program off to a fresh start. While we are in transition, the March luncheon is cancelled.

Census Results Just Out - Area A Down 14%: What's up with these numbers?

Here are the new population tables from the most recent census conducted in the Lower Columbia region for 2021. Data shows that Fruitvale had a 2% growth rate; a consistent trend over the past years. Area A shows a **14% decline in population.** After some detective work on my part, and a detailed email exchange with Stats Canada contracted staff, I learned that the numbers are **wrong!**

What is it used for and how often is it done?

The national census is conducted by Statistics Canada every five years. The census provides demographic and statistical data that is used to fund public services including health care, education, and transportation; to determine federal transfer payments; and to calculate the number of Members of Parliament for each province and territory. The data helps to build the <u>right</u> programs for Canadian families and provides some of the most crucial information for government planning. For example, census data was used to calculate the purchase of COVID-19 vaccines for our country.

Common reasons for not completing the forms & how we know 2021 is wrong?

There are many reasons for not wanting to complete the forms; some people don't care, or don't understand how it will benefit them or their community; some worry about confidentiality and privacy; the reasons vary. However, for the most part, it seems like many people in Area A were not given the opportunity to BE counted. According to one of the census workers, a number of the coded packages slated for hand delivery were mixed up and the workers got the wrong packages for specific neighbourhoods. Although the mistake was caught during house to house deliveries, attempts to fix the errors went unheeded at the regional level. Since uncovering this fairly significant mistake, I have reached out to the Regional District and to the Kootenay South MLA Richard Cannings to seek assistance and guidance for an appeal and a correction on the inaccurate data.

Why are these numbers important?

There is a *significant amount of money* that gets transferred from the federal government to the provincial and territorial governments for health and social programs. The amounts of those transfers are done on a per capita basis, counting every person in the provinces and the territories, so the overall tally - including YOU - goes toward calculating federal transfer payments. If you have not been counted via the census, we lose the funding intended for you, your family and for our community! **I will make every effort to correct this shortfall, including a request for a review of the process, so that future errors will be prevented.**

I hope March finds everyone happy and healthy; the longer days certainly brighten our lives.

Fruitvale Council is currently in the decision-making process on re-zoning a piece of property across from the cemetery and adjacent to Mazzochi Park that would allow a proposed Fortis substation to be built there in 2024-25. Fortis has indicated in their long-term plan that the existing substation near the 5-way intersection is too small to address future expansion as load grows with electric vehicles and additional residents. Fortis has explored other potential sites and has focused on this site as the best option. Fruitvale owns about 25% of the land that is proposed for re-zoning and a private owner the rest. Council recently agreed to sell Fruitvale's piece to Fortis pending a proposed zoning and official community plan amendment that would change the zoning and the land use to be consistent with the zoning and land use of the Cemetery across the street.

Council has supported moving forward with this substation proposal thus far because the piece of land Fruitvale owns is too small to support future Cemetery expansion, the number of residents impacted is less than the current substation, the appearance will be much improved over the current substation with a decorative fence/wall around it, and the technology is much safer with shielded transformers to limit EMF radiation. Financially, the ongoing benefits beyond the sale of the property is the payment of 1% of power sales in Fruitvale plus taxation on the property which add up to approximately \$22,000 annually (which will grow as electricity sales increase) with no servicing costs for the lot which equates to an approximate 4% tax increase at no cost to residents. We do recognize that finances are not the only concern, however taxation levels have been the main concern we have heard over the years.

I encourage any interested Fruitvale residents to attend our open house on the proposed rezoning on March 8 from 5:00 - 7:00pm. No decision will be made at this meeting - the meeting is our residents' opportunity to respectfully comment and share thoughts with Council regarding the proposed rezoning of the property. The meeting will be structured to allow everyone to speak for up to three minutes, after everyone has the opportunity to speak once, if anyone has something new to add they will be allowed a further two minutes to speak. It is incumbent on Council and the public to attend this Hearing with an open mind, listen to all comments, and process the feedback, then at a later meeting with all the information gathered over the past few months Council will decide on the best path forward for the Community.

DID YOU KNOW... When is a Building Permit Required?

Building Permit is required:

- construct a new home
- construct a new accessory building such as a carport, garage or storage shed
- construct a farm building
- construct a commercial, industrial or public use building
- renovate existing buildings
- undertake any structural work such as interior partitions
- enclose a porch or roof over a sundeck
- move a building
- · locate a mobile home
- roofing and re-roofing a structure
- reconstruct after damage (i.e. fire)
- exterior finish, such as stucco or siding

Building Permit is not required:

- painting
- landscaping, sidewalks, driveways
- fencing (fence height must comply with Regional District/Municipal zoning bylaws where applicable)
- cupboards

Plumbing Permit is required:

- new houses, additions, renovations when drawings indicate fixtures
- a plumbing system is constructed, extended, altered, renewed, or a connection made to a sewer or sewage disposal system

Plumbing Permit is not required:

• a fixture, valve or faucet is repaired or replaced, a stoppage cleared or a leak repaired if no change in the piping is required

Building permits are issued from the Building Department at the Regional District of Kootenay Boundary.

Streetlights

Residents are asked to report any non-working streetlights to the Village Office by email to info@village.fruitvale.bc.ca or phone, 250-367-7551.

When reporting the non-working light to the Village Office please have the number listed on the pole (yellow with black numbers), the street address of the house closest to the pole and the problem with the light, whether it is completely out or flashing on and off. We will then report the light to Fortis BC for repair.

2022 Village of Fruitvale Water, Sewer and Garbage User Fees

The 2022 water, sewer and garbage utility bills were sent out March 1. A 5% discount is offered until March 31 on utilities and extra packages of garbage bags. If you have not received your utility bill by March 15, please contact the Village Office.

Village Office payment options are as follows:

- Cheques, bank drafts and/or money orders hand delivered, mailed to or placed in the drop box at the Village Office;
- Online banking through your financial institution (Royal Bank and TD Bank excluded);
- E-transfers sent to:

finance@village.fruitvale.bc.ca - Please reference your roll number, property address and what you are paying. A password is not required for the e-transfer as the Village is set up as an automatic deposit.

The Village of Fruitvale has a monthly preauthorized prepayment plan for utilities and property taxes. This is a **pre**payment plan for next year's utilities and property taxes. Current charges must be paid before the prepayment plan can begin. For more information and details on the preauthorized prepayment plan, please contact the Village Office.

The package of garbage bags included with the utility billing can be picked-up beginning March 1. The Utility Fees do not need to be paid before picking up this package of bags.

COMMUNITY VOLUNTEER INCOME TAX PREPARATION - Free Income Tax Service for Greater Trail Residents

This **free** service is available to low-income individuals who satisfy certain limits and restrictions. No appointments; interviews are on a first-come basis. Please arrive at least 15 minutes before the posted closing time. Due to COVID-19 the returns will be a done by a modified drop off process.

Annual income maximum guidelines are as follows:

Single person \$35,000 Two persons in family \$45,000

More than two persons \$2,500 for each additional person

Persons with investment/interest income in excess of \$1,000, capital gains/losses, partnership income, rental income, business or professional income, farming or fishing income, bankruptcy, or anyone with complex deductions may be deemed **ineligible** for this service. Also, we are unable to prepare final returns for deceased persons. Other limitations may apply.

COVID-19 protocols are in place so wear your mask and maintain social distancing. Returns will not be completed on site as was an option in prior years.

March 1 to April 30 from 9:00am to 11:00am at three locations listed as follows:

Tuesday at **Trail United Church**, 1300 Pine Ave, Trail. Last interview April 19. Last date for pickup April 26.

Wednesday at the **Royal Canadian Legion**, 2141 Columbia Ave, in East Trail, (next to Columbia Glass.). Enter via ramp at south end. Last interview April 20. Last date for pickup April 27.

Thursday at **Waneta Plaza**, where Ricki's used to be. Last interview April 21. Last date for pickup April 28.

Be sure to bring all essential documents and receipts to the interview. We require a piece of government photo ID. If possible, bring your copy of the previous year's return and/or the CRA Notice of Assessment for the previous year. You will be asked to complete a questionnaire that we will use to complete your taxes.

If you are eligible to receive the GST credit or other credits, you **must** file a tax return, by May 2 to ensure timely receipt of quarterly payments which commence at the beginning of July.
