BYLAW 985, 2025

A Bylaw to Provide for an Annual Indemnity to Members of Council

WHEREAS Council may provide for the paying out of the annual revenue an annual indemnity to the Mayor and Councillors;

NOW THEREFORE, the Council of the Corporation of the Village of Fruitvale in open meeting assembled enacts as follows:

1. ANNUAL INDEMNITY

- a. There shall be paid out of the annual revenue of the Village of Fruitvale an annual indemnity to the Mayor in the amount of SIXTEEN THOUSAND AND EIGHTY-FOUR DOLLARS (\$16084.00).
- b. There shall be paid out of the annual revenue of the Village of Fruitvale an annual indemnity to each Councillor in the amount of EIGHT THOUSAND AND FORTY-ONE DOLLARS (\$8,041.00).

ADDITIONAL ANNUAL INDEMNITY FOR DEPUTY MAYOR APPOINTMENT

- c. The appointed Deputy Mayor shall be paid out of the annual revenue of the Village of Fruitvale an additional annual indemnity in the amount of FIFTEEN PERCENT (15%) more than the current Councillor indemnity.

2. INSTALLMENTS

Each of the indemnities shall be paid monthly in equal installments at a time to coincide with employee payment dates.

3. EXPENSE ALLOWANCE

- a. One-third of the indemnity paid to the Mayor, Deputy Mayor and to each Councillor shall be paid as an allowance for expenses incidental to the discharge of the duties of the office.
- b. If the Mayor, Deputy Mayor or any Councilor incurs expenses over the amount described in subsection (3) (a), an additional allowance may be paid out of the annual revenue of the Village of Fruitvale to reimburse such expenses as approved by Council resolution.

4. PAYMENT

- a. Payment of the indemnities set out by this bylaw shall be applicable from July 1, 2025 and thereafter until this bylaw is amended or repealed.

- b. The Mayor and Councillor indemnities shall be adjusted according to the Province of BC Consumer Price Index at December 31st on an annual basis.

5. REPEAL

Village of Fruitvale Council Indemnity Bylaw No. 917, 2020 and all amendments thereto, are hereby repealed.

6. CITATION

This bylaw may be cited for all purposes as the "Village of Fruitvale Council Indemnity Bylaw 985, 2025".
